Additional costs could be incurred for conversion from a prior EHR, Practice Management software integration, HL7 integration and training.</li> <li>• Ongoing monthly costs to support DrFirst Rcopia for electronic prescribing are per provider at a flat monthly rate. Each provider must sign an agreement with DrFirst.</li> <li>• For use of EMR Direct, secure email, the provider pays a setup fee, to establish the provider’s secure email address, and an ongoing domain name fee. There is no limitation on the number of messages being sent. The use of EMR Direct messaging capability is restricted and users will be unable to exchange messages with third party HISPs who are not part of a trust community. EMR Direct is a member of the Direct Trust Network.</li> <li>• For Concord faxing, the provider pays a setup fee. The first 500 pages per month are free, then there is a nominal charge per page for all subsequent pages.</li> </ul>

That contract does not contain limitations for the certified capabilities.</li> <li>• There are no required contracts for third-parties as it relates to certified capabilities. However, third-party software is integrated within the IntellectChartPRO product.</li> <li>• DrFirst is used for e-prescribing and</li> <li>• EMR Direct is used for Direct Messaging.</li> <li>• These third-party vendors are integrated within the software, therefore the client cannot choose another service for integration purposes for these services.</li> </ul>
